to facilitate the construction of Cushaling Wind Farm – Relating to the following road in County Kildare: L3001

**NOTICE IS HEREBY GIVEN** that, in exercise of the powers vested under Section 10 of the Road Traffic Act 2004, as amended, and in the interests of road safety, Kildare County Council has made a Road Works Speed Limit Order applying the Road Works temporary Speed Limits at the levels and locations and for the periods specified below.

Period: from Wednesday, 05<sup>th</sup> April 2023 to the Thursday, 04<sup>th</sup> April 2024 or such earlier date as may be determined by Kildare County Council

Location: L3001, Rathangan – Edenderry Road, starting at the Bog Cross Roundabout (R401) coordinates Eastings -666357, Northings - 719950 and ending at Cushaling Bridge on the Kildare/Offaly Bounds coordinates Eastings 665013, Northings - 725883

Default permanent speed limit (KM/H): 80

Temporary speed limit to apply (KM/H): 50

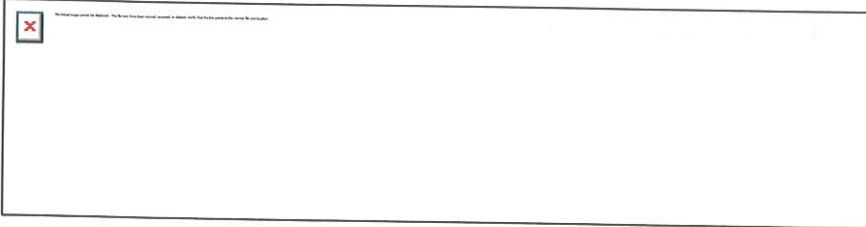
