Tugtar fógra leis seo go bhfuil Comhairle Contae Dhún na nGall, i bhfeidhmiú na gcumhachtaí atá dílsithe di faoi Alt 9 den Acht um Thrácht ar Bhóithre 2004, tar éis Dréacht-Fhodhlíthe Luasteorainneacha arna leasú 2024 a ullmhú do limistéar riaracháin Chomhairle Contae Dhún na nGall i ndiaidh di athbhreithniú ar luasteorainn ar fud an chontae a dhéanamh de réir na dtreoirínte 2015 atá eisithe ag an Roinn Iompair, Turasóireachta agus Spóirt (agus leasúchán ina dhiadh sin) maidir le teorainneacha luais a chur i bhfeidhm in Éirinn.

DRAFT ROAD TRAFFIC (SPECIAL SPEED LIMITS) (COUNTY OF DONEGAL) (AMENDMENT) BYE LAWS 2024

Notice is hereby given that Donegal County Council, in exercise of the powers vested in it by Section 9 of the Road Traffic Act 2004 has prepared Draft Speed Limit Bye Laws Amendment 2024 for the administrative area of Donegal County Council following a countywide review of speed limits in accordance with the 2015 guidelines issued by the Department of Transport Tourism and Sport (and subsequent amendments) for the application of speed limits in Ireland.

- i. The purpose for which the Draft Speed Limit Bye Laws Amendment 2024 are to be made is to provide for a more appropriate speed limit on rural local roads, certain national road locations and public roads within certain housing estates.
- ii. The Draft Speed Limit Bye Laws Amendment 2024 is available for inspection online at consult.donegal.ie or during normal office hours (Mon - Fri from 9.00am - 12.30pm and from 1.00pm - 5.00pm) at the Council's Offices at -
